Section 21 of the Community Justice (Scotland) Act 2016 requires that a Participation Statement be prepared by the statutory partners. The statement must set out the action taken by the statutory partners to achieve the participation of third sector bodies and community bodies involved in community justice for the local authority area in the preparation of the plan¹.

This paper sets out local consultation that has taken place across Dumfries and Galloway to date. We have also been involved in wider consultation at both a Community Justice Authority² and a national level as appropriate.

The Dumfries and Galloway Community Justice Partnership see this participation statement as a living document and although this was prepared as part of our initial plan, participation will remain ongoing and will be evidenced within our Outcome Annual Activity Returns that go to Community Justice Scotland in September every year; membership of our local partnership also clearly evidences third sector engagement. All of this will enable participation to be viewed as a process rather than a stand alone piece of work, ultimately making us more accountable to the communities we serve. As part of our local Community Justice Outcomes Improvement Plan we aim to develop a short, easier to read version of the plan which will aid community consultation moving forward. One of our key actions for the first year of the partnership was to work on a robust communication strategy and the development of a user friendly, interactive website to include the work of the wider partnership and showcase the positive work of all partners and communities; this has now been superseded by a Community Justice section within the D&G Public Protection website.

We recognise that in order to consult effectively we must utilise the skills and networks of all the partners, linking in a meaningful way with communities and using established services and community groups often led by the third sector.

The Dumfries and Galloway Community Justice Partners are committed to:

- Involving all relevant stakeholders, communities and members of the public in the development of policies that will impact upon them;
- Make arrangements for participation which is inclusive, clear and transparent;
- Provide communication in a range of formats and ensure it is jargon free and easy to understand;
- Ensuring that contributions made by all participants are respected

The Dumfries and Galloway Community Justice Outcomes Improvement Plan was viewed over 600 times by utilising twitter, LinkedIn, Facebook and websites (Dumfries and Galloway Council, NHS Dumfries and Galloway, South West Scotland CJA). It was also shared with colleagues on Knowledgehub and via CJVSF⁵.

We received 20 written responses to the consultation and the plan was updated to reflect feedback, although on the whole all feedback was extremely positive. Particular mention was given to the title of the plan and the fact it was easy to read and follow. Production of an even easier to read, short version of the plan is an action for the partnership moving forward. This can then be used to help engage communities. This document will continue to be reviewed and updated throughout the lifetime of the partnership.
