5. Next Steps

The National Guidance Implementation Group has been formed to undertake detailed implementation planning and to support each local authority. D&G's implementation group met on 11.11.2021 and agreed its membership, roles & responsibilities. Monthly meetings will be arranged as of January 2022 to initially identify the challenges and opportunities. This revised child protection flowchart will be the interim process until full implementation of the 2021 National Guidance.

2. Background

The recent publication of the National Guidance for Child Protection *replaces* the previous 2014 guidance incorporating a number of important policy, legislative & practice developments. It sets out the responsibilities and expectations of everyone involved in protecting children and young people (e.g. practitioners working in health, police, social work, third sector, local authority and education settings).

The guidance integrates the principles of GIRFEC, strengthens the focus on children's rights (UNCRC) and aligns with the ambitions of The Promise.

3. The New National Guidance

While the publication of the National Guidance for Child Protection is a key milestone, it is not an end in itself.

The Scottish Government recognises that frontline staff in all agencies continue to experience unprecedented pressures & demands from the pandemic, and therefore an 18-24month implementation timescale has been given

4. What's changed?

The 2021 guidance builds on the four-part structure of the 2014 guidance, by adding a new section. Part 2(b): Approach to multi-agency assessment in

child protection (new section)

The key differences include some changes in terminology which we will be adopting locally, for example, Initial Referral Discussions will become Inter-Agency Referral Discussions and Child Protection Case Conferences will become Child Protection **Planning Meetings**

The new guidance changes some child protection timescales which will not affect us locally as these now align with our Signs of Safety timescales, previously agreed through Public Protection Committee. It incorporates the new model for Joint Investigative Interviewing of Children, requires us to consider children up to the age of 18 and includes detail on Health Assessment and Medical Examination.
